## A. General Release of Liability and Waiver

To fully release, discharge and hold harmless the Organizer and its respective members, director, agents, employees, associates, staff and independent contractors from any claims, actions, liabilities and causes of actions which I I and my horse(s) may now have or which may accrue as a result of or incidental to may voluntary participation in any of the sporting or non-sporting activities incidental to or in connection with the Competition.
