



COMPETITION GENERAL RELEASE OF LIABILITY AND WAIVER FORM

PLEASE READ CAREFULLY BEFORE SIGNING THIS FORM MUST BE SIGNED BEFORE YOU COMPETE

In consideration of EQUESTRIAN ASSOCIATION of MALAYSIA (EAM) Organizing Committee (hereinafter referred to as the 'Committee') granting me permission to participate in the **PRIME MINISTER CUP CSI1* & CSIJ-B BORROWED HORSE PRESENTED BY ELEMENT X STRATEGIES** other classes (hereinafter referred to as the 'Competition') **24 - 26 JULY 2026** agree: -

A. General Release of Liability and Waiver

1. That prior to participating in any event, I will inspect the facilities and equipment to be used by me during that event and agree that the facilities and equipment are in good condition.
2. That I understand that I and my horse(s) may be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result from my actions or in actions, but also from the intentional negligent acts of others, from the rules of the Competition and their application, from the condition of the premises and/or the equipment, and from other causes now unknown or not now reasonably foreseeable: and
3. To fully release, discharge and hold harmless the Organizer and its respective members, director, agents, employees, associates, staff and independent contractors from any claims, actions, liabilities and causes of actions which I I and my horse(s) may now have or which may accrue as a result of or incidental to may voluntary participation in any of the sporting or non-sporting activities incidental to or in connection with the Competition.

B. Acknowledgement of Rules and Regulations.

1. To abide by all the rules and regulations of the organizer as in force from time to time;
2. To refrain from consuming alcoholic beverages or using any substances in a manner which would decrease or impair my level of performance during my participation in the sporting activities or competition.
3. To refrain from unsportsmanlike conduct or any conduct bringing discredit upon the competition including without limitation physically or verbally assaulting or abusing any official, competitor, spectator, volunteer or any person involved in the conduct and management of the competition and that any such conduct may meet with expulsion from the competition and appropriate criminal or civil action against me, and
4. To be filmed, photographed or interviewed as a participant in the competition when requested to do so by any officer or official of the organizer. I acknowledge that I execute this "General Release of Liability" freely and voluntarily, and I do not rely on any inducements, promises or representations made by the aforementioned organization or individuals involved in the Competition, or any person associated in any way with the Competition.
